




The field is fenced pasture with mowed grass and natural terrain. SISFA reserves the right to alter the course diagram as required by weather and/or field conditions on the day of the trial.

#### ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, and Whippets may be entered in the regular stakes. Provisional breeds may be entered in the Provisional Stake or the Singles Stake. Provisional breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A <u>printed</u> photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

INCOMPLETE, UNSIGNED OR CONDITIONAL ENTRIES WILL NOT BE ACCEPTED. Entries will not be acknowledged by mail or telephone. Email, IM or text Kaylie or Emily for confirmation.

#### REGULAR STAKES OFFERED

Open Stake: Any eligible sighthound excluding ASFA Field Champions of record that has met certification requirements.

Field Champion Stake: Any ASFA Field Champion.

Veteran Stake: Any eligible sighthound that has met certification requirements and whose age exceeds six years, except Irish Wolfhounds, whose age shall exceed five years and Afghans, Ibizan Hounds, Ridgebacks, Salukis, and Whippets who must be at least seven years old. Points go toward V-Fch or V-LCM titles.

<u>Provisional Stake</u>: Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

<u>Singles Stake</u>: Any eligible sighthound, including those disqualified to run in other stakes. Not eligible to run in Best of Breed or Best in Field, but are eligible to earn TCP and CPX titles from this stake.

Best in Field: Offered Saturday and Sunday.

<u>Lure Coursing Instinct (LCI) Stake</u>: Open to NON sighthounds and sighthound mixes. (See insert for description.) No Entry Limit.

#### **GENERAL INFORMATION**

• All entries must be one year or older on the day of the trial, and have a completed hound certification form if entered in open or veterans stake for the first time. • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. • Bitches in season, hounds with breed disqualifications, and lame hounds will be excused at Roll Call and the entry fee will be refunded. • Spayed, neutered, monorchid, and cryptorchid hounds without breed disqualifications may be entered. • Hounds with breed disqualifications are not eligible to enter except in the Single Stake. • Hounds not present at time of Roll Call will be scratched without refund of entry fee. • Any hound that displays aggressive behavior during trial hours will be excused for the day without refund of entry fee. • All hounds will run twice in trios, if possible, or braces (except in the Single Stake) unless excused, dismissed, or disqualified. • A penalty of \$5.00 will be assessed for any loose hound not competing in the course in progress. • A penalty of \$5.00 will be assessed for any waste material left on the grounds by a dog or person. Waste disposal equipment and containers will be available. • There will be no certification runs during the trial and will be offered per judges' availability • Battery powered, continuous loop lure machine will be used with highly visible plastic strips; backup equipment will be available.

## LURE CHASING INSTINCT (LCI) STAKE

This is a recently added test that is open to NON sighthounds and sighthound mixes. All entries shall be individually registered with the AKC (including ILP & PAL) or the UKC. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry.

**Small Open:** for dogs 17½ inches or less at the withers and / or brachycephalic ("flatfaced") dogs who have not achieved the title of LCC.

**Small Excellent:** for dogs 17½ inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

**Small Veteran:** for dogs 17½ inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

**Large Open:** for dogs over 17½ inches at the withers who have not achieved the title of LCC.

**Large Excellent:** is for dogs over 17½ inches at the withers who have achieved the title of LCC.

**Large Veteran:** for dogs over 17½ inches at the withers who are over the age of 7 years.

**Sighthound Mix Open:** for dogs with a sighthound breed in its background who have not achieved the title of LCC.

**Sighthound Mix Excellent:** for dogs with sighthound breed in its background who have achieved the title of LCC.

**Sighthound Mix Veteran:** for dogs with sighthound breed in its background over the age of 7 years.

When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.



### **COURSING AND SOCIAL NOTES**

First aid supplies will be available at the field. There is an animal emergency clinic 25 minutes away:

Motor homes and camping are welcome on the field, but this is a working ranch, so please keep the noise to a minimum, pack out your trash, and ensure that any fires are contained.

We will have coffee and donuts on the field each morning, and bottled drinking water will be available throughout the day. (A donation for these items is appreciated.) Sorry, only a limited amount of shade will be provided, primarily for use by the judges and field committee.

The field will be set up for practice runs (@ two runs for \$5) when there is time available, and we will have a judges available for certification runs at \$10 per hound certifying. Contact Emily or Kaylie the week before the trial if you have questions. SISFA will NOT provide by-dogs, so please make sure you have a dog to certify with. There will be no certification runs during the weekend except as approved by the Field Chairman or Trial Secretary, per Judges' availability. Absolutely NO certification runs will be done during the trial! Practice runs during the weekend will only be done if there are volunteers for field crew (including lure operator) and ONLY if there is time after the field has been reset. ALL equipment MUST be left in an operable state!

Please remember the entry for all first-time-entered dogs must include a copy of their current registration, and either a hound certification or a certification waiver. A copy of current registration is also required if ownership has changed since a dog's last entry. Entries cannot (and will not) be accepted without this!

One last reminder: the weather in Idaho is always unpredictable. In early May it is typically clear and sunny, with crisp mornings and cool afternoons. Nevertheless, don't forget your sunscreen, polar fleece, and rain gear
