Eligible Breeds:

Only purebred Silken Windhounds may enter. All entries shall be individually registered with the Silken Registry (ISWS), UKC, an ASFA recognized foreign or ASFA Board approved registry.

Stakes Offered:

OPEN STAKE – Open to any eligible Silken Windhound excluding ASFA Field Champions of record, that have met certification requirements.

FIELD CHAMPION STAKE - Open to Silken Windhound ASFA Field Champions.

VETERAN STAKE – Open to any eligible Silken Windhound whose age is over 6 years, on the day of the trial. Points and placements go towards the V-FCh and V-LCM titles

SINGLES STAKE – Open to any eligible Silken Windhound including those disqualified to run in other stakes Not eligible for Best of Breed. Hounds will run alone.

BEST IN FIELD – Will not be offered

Any exhibitor or participant who shows any sign of illness prior to or during the event will be asked to leave the trial site, and their entry fees will be refunded in full. Any exhibitor or participant unable or unwilling to adhere to the safety guidelines will be asked to leave the trial site.

Conditions of Entry:

Hounds must be one year or older on the day of the trial. All hounds will run twice, in trios if possible or braces unless excused, dismissed or disqualified. Bitches in season and lame hounds will be excused. Substitutions for in season or lame hounds will be permitted prior to roll call. Hounds not present at the time of roll call will be scratched after a five-minute grace period. Each entry will be examined at inspection for breed disqualifications. Hounds determined to have a breed disqualification at the time of roll call shall be barred from competition and their entry fees shall be refunded. Spayed, monorchid, cryptorchid, and neutered hounds without breed disqualifications may be entered. Regular stakes will be split if 20 or more entries are present in any one stake at the time of the draw. Any hound that displays aggressive behavior during trial hours will be excused for the day. A penalty of \$5 will be assessed for any loose hound not competing in the course in progress.



Course Plan:

Saturday's course is 640 yards, Sunday's course is 620 yards, direction reversed for Finals and BOB. Start direction shall be at the judges' discretion. Hounds need to be in top physical condition due to the high elevation. USRCC reserves the right to alter the course diagram as required by weather and/or field conditions on the day of the trial..



Equipment & Field Information:

Terrain is a mowed grass polo field. Hounds need to be in top physical condition due to the high elevation. Battery powered continuous loop machine will be used and backup equipment will be available. Lure will consist of white and/or black plastic strips.
